Impact Grants Information and Guidelines





General Information

Community Housing Ltd is seeking to remove barriers for the communities we work with by offering grants to tenants living in CHL/ACHL properties*.

The impact grants initiative aligns with the values and principles outlined in the CHL Social Impact Framework and Community Development Framework.

The funding is broken down into three categories:

- **Education & Employment**
- **Social Connection**
- Community

The funding can be paid directly to the provider, or to the tenant upon presentation of a receipt.

Tenants who are Aboriginal, Torres Strait Islanders or of diverse cultural backgrounds are encouraged to apply.

^{*}Anyone living in northern Tasmania can apply, not just CHL/ACHL tenants.

Eligibility

- Any person who is living in a CHL/ACHL property (Note: Anyone living in northern Tasmania can apply, not just CHL/ACHL tenants).
- Any person who is receiving support from CHL/ACHL Homelessness Services.
- Applicants must not currently be in receipt of another grant.
- Applicants must not have received any funding from CHL/ACHL in the past 12 months.
- There is no age restriction for applicants.

When can I apply?

Applications can be received all year round, however there only two assessments.

Assessment 1

- Assessment deadline for round 1 applications 28 January 2022
- All applicants will be notified of receipt of application
- The successful/unsuccessful applicants will be informed within 30 days of the deadline

Assessment 2

- Assessment deadline for round 2 applications 29 July 2022
- All applicants will be notified of receipt of application
- The successful/unsuccessful applicants will be informed within 30 days of the deadline

How to Apply

The following guidelines must be followed to ensure all applications are equally assessed:

- Application form (online or hard copy) must be completed in full and signed by applicant or support worker/agency (or parent/guardian if applicant is under 16).
- CHL/ACHL staff can assist people to complete their application
- The applicant must provide contact details of any course or activity provider, so CHL can contact them to confirm the course.
- Where possible, supporting documentation should accompany any item listed in the funding breakdown section of the application form.
- Only complete and signed applications will be accepted.
- Applications must be received before 5pm of the deadline date
- Late applications will not be considered. No extensions are available.
- Applications can be received online (web form), email (impactgrant@chl.org.au), post or in person at your local office.

Assessment

Each application will be assessed on the following criteria:

No.	Consideration	Weighting
1	The application has a clear goal and purpose	10%
2	The application demonstrates a high level of research or understanding of what they want to achieve	20%
3	The application addresses the priorities impacts areas associated to that grant	30%
4	The application confidently demonstrates how the activity or project will be completed (delivery plan, address barriers)	30%
5	The application aligns with at least one value outlined in the CHL Social Impact Framework (https://chl.org.au/our-social-impact-framework/) or CHL Community Development Framework (https://chl.org.au/wp-content/uploads/CHL-Comm-DevelopmentFramework.pdf)	10%

The Assessment Process

- Applications are assessed by the national impact grants panel.
- The panel is made up of representatives from across Australia and facilitated by the National Community Development Manager, including:
 - 1 x Corporate Services team member
 - 1 x Assets team member
 - 1 x Senior Manager (any team)
 - 1 x Projects team member
 - o 1 x Community Development or Business Improvement team member
 - 1 x External Sponsor
- For governance reasons there will be no Housing Officers on the panel, or anyone that has assisted with an application.
- Where possible, the panel will ensure an even distribution of grants between states NOTE: Due to local sponsors in Tasmania, a further TAS only meeting may be held pending application demand.
- The panel will select successful applicants based on their eligibility and responses to address assessment criteria.
- Successful and unsuccessful applicants will be contacted within 30 days of the assessment deadline date.
- Feedback can be provided to any unsuccessful applicant upon request.

Priority impacts areas

The following are current priorities relating to each grant category:

Education & Employment

- Improving people to access or further their education
- Enable employment opportunities
- Remove barriers to access opportunities relating to education or employment/training
- Building the capacity of individuals

Social Connection

- Improving the health and well-being of people
- Removing barriers to social inclusion
- Connecting people and assisting people be involved in their community
- Building the capacity of individuals

Community

- Removing barriers for people and community
- Bringing the community together
- Building the capacity of people and encourage an empowered community
- Involvement of community members to deliver the project, particularly CHL/ACHL tenants
- Clear benefits to community with social objectives

Funding Conditions

- The funding amount provided is final, and no further requests for financial assistance will be made by the grant recipient to CHL/ACHL.
- All funding is directly for the purposes outlined in the application, and as such, only that amount will be awarded.
- Awarded funding is to be paid directly to the activity provider, or to the tenant upon presentation of a receipt for fees paid.
- If grant funding is to be paid directly to the activity provider, the tenant must provide an invoice from the activity provider in the name of CHL/ACHL so that fees can be paid directly to the provider. The invoice must contain:
 - Business Name
 - o ABN
 - o Contact name
 - o Business Address
 - o Contact number
 - Contact email
 - o Invoice number
 - Details of activity
 - o The \$ amount no greater than the grant amount awarded
- If activity fees exceed the amount awarded, this amount will be the responsibility of the recipient.
- If the activity/course of the recipient is enrolled in does not proceed, all funding paid to the training provider is to be refunded to CHL/ACHL. The recipient will need to contact CHL/ACHL within four weeks to advise of an alternative study option, otherwise the funding will be forfeited.
